

CDPH/OSP Youth Suicide Prevention Media and Outreach Campaign

<u>Campaign Goal:</u> Reduce suicide ideation, attempts, and deaths by increasing awareness and utilization of resources, services, and supports among California youth up to age 25 who are disproportionately impacted by suicide.

Three main project components:

- A media campaign, co-created with youth. The primary audience includes youth who are Black/African American, Hispanic/Latinx, and/or American Indian/Alaska Native. Intersecting populations include youth from the primary audience who also identify as 2S/LGBTQIA+, having had mental health or substance use challenges, and/or having been involved in the foster care system.
- Community-level suicide prevention projects implemented by 34 CBO and tribal entity grantees, which will amplify and reinforce campaign messaging.
- Comprehensive evaluation to assess the overall impact of the project and identify promising suicide prevention practices.

















CDPH/OSP Youth Suicide Reporting and Crisis Response Pilot Program

<u>Program Objective</u>: Develop and test models for rapidly reporting and comprehensively responding to youth suicides and suicide attempts at the county level by providing crisis services and follow-up supports within school and community settings.

Ten high-priority counties selected to participate:

Alameda, El Dorado, Humboldt, Kern, Los Angeles, Riverside, Sacramento, San Diego, San Joaquin, and Solano

The pilot program will be designed by each county to:

- Complement and expand upon existing supports and services
- Identify and shrink gaps in rapidly reporting youth suicide deaths and attempts
- Strengthen rapid responses to suicide deaths and attempts to initiate crisis response services

Overview of Campaigns



State Level Campaign

Co-designed and implemented through a lens of reducing disparities and addressing inequities to reduce stigma and enhance behavioral health literacy for unserved and underserved children and youth, parents and caregivers.

Local Level Campaign

Co-designed and delivered messaging campaigns at the community level to address the need to shift attitudes, beliefs, and behaviors surrounding mental, emotional, and behavioral health in priority populations.



Both campaigns will be youth centered and co-created representing five priority populations: African Americans/Black, Native Americans, Asians and Pacific Islanders, Latinos, and LGBTQ+ communities with special consideration for transitional-age youth, persons with disabilities, justice and foster care involved youth, and those living in rural areas.

On February 20, 2024, through The Public Health Institute Center for Wellness and Nutrition, CDPH awarded \$25 million to 28 community based and tribal organizations.













Current Status - CYBHI fee schedule

Progress to date

DHCS developed (in compliance with statute¹):



"A school-linked statewide fee schedule for outpatient mental health or substance use disorder treatment provided to a student 25 years of age or younger at a school site"



"A school-linked statewide provider network of school site behavioral health counselors"



Policy stating that "providers of medically necessary school site services described in this section shall be reimbursed, at a minimum, at the fee schedule rate or rates... regardless of network provider status"

Path forward

Prior to providers and practitioners being reimbursed for CYBHI fee schedule services:



- CMS approval allows the CYBHI fee schedule to proceed, by:
- » Providing directed payment authority²
- » Approving the State Plan Amendment to enable reimbursement of Pupil Personnel Services (PPS) credentialed providers





HCAI Program Highlight: Health Professions Pathways Program (HPPP)

Purpose:

- Recruit and support students from underrepresented regions and backgrounds to pursue health careers
- HPPP awards help organizations build and expand:
 - Pipeline programs
 - Summer internships
 - Post Undergraduate Fellowships
 - Post Baccalaureate Scholarships *New for Cycle 2*

Impact:

- Cycle 2: Closed on October 31, 2023. Awards will be announced soon.
- Cycle 3: will open in August 2024.

















HCAI Program Highlight: Behavioral Health Scholarship Program

Purpose:

- Increase the number of appropriately trained behavioral health professionals providing direct patient care in an underserved area or qualified facility within California.
- In exchange for a 12-month service obligation practicing and providing direct patient care in an underserved community, eligible applicants may receive up to \$25,000.

Impact:

Cycle 2 will open in April 2024.

















HCAI Program Highlight: Social Work Training Stipends & Fellowships

Purpose:

 Funds behavioral health training, MSW stipends and post-graduate fellowships for persons seeking clinical licensure

Impact:

- Beginning FY 24-25, the Behavioral Health Social Work Training & Fellowship program will continue through a partnership with a new institution.
- 192 stipends were awarded in Fall 2023.

















Deep Dive: Behavioral Health Virtual Services Platform Updates

Behavioral Health Virtual Services Platforms

- » On January 16, 2024, DHCS launched two free behavioral health services applications for all families with children, teens, young adults, and their caregivers, regardless of insurance coverage or immigration status:
 - BrightLife Kids is for parents/caregivers and kids ages 0-12.
 - Soluna is for teens and young adults ages 13-25.
- » The platforms were designed with input from more than 1,000 children, youth, families/caregivers, behavioral health professionals, and subject matter experts.
- » Platforms are a cornerstone of Governor Newsom's <u>Master Plan for Kids' Mental Health</u> and the <u>CYBHI</u>.





Introduction to the Behavioral Health Platform





BrightLife Kids and Soluna Offerings

- Professional Coaching: Live 1:1 (or 2:1 for younger children and parents/caregivers) coaching sessions through in-app chat or video visits. Telephone coaching will also be available in all Medi-Cal threshold languages with the assistance a Language Line interpreter.
- Educational Content: Age-tailored educational articles, videos, podcasts, and stories.
- Assessments and Tools: Stress-management tools and clinically validated assessments to understand and monitor behavioral health over time.

- Peer Communities: Pre-moderated forums and programs to connect users with other youth or caregivers.
- Crisis and Safety Protocols: Crisis and emergency safety resources for people experiencing a mental health crisis or who require immediate assistance.
